**2023 COMMERCIAL POLE BARN 80'x120'x18'**

**BID SPECIFICATIONS**

Part 1 - General

1.1 Description

The work to be done shall consist of furnishing all labor, materials and equipment for the complete and satisfactory construction of a 80'x120'x18' commercial pole barn. All work shall be completed by December 15, 2023.

1.2 Submittals

- A. Contractor must comply with MIOSHA standards and regulations.
- B. Contractor is responsible for permits and fees from the City of Corunna.
- C. Contractor must possess and produce copy with bid of:
  - 1. Commercial general liability insurance
  - 2. Automobile liability insurance
  - 3. Excess liability insurance
  - 4. Worker's Compensation
  - 5. Contractor/Builder's license
  - 6. Engineered blueprint for commercial pole barn
- D. Full payment will be made upon completion of work.

Part 2 - Specifications

2.1 80'x120'x18' Commercial Pole Barn

- A. Cement piers
- B. Skirtboards 2'x6' tongue and groove treated, 4 rows high
- C. 24" overhang with vented soffit on side walls and end walls
- D. Bird screen for all overhangs
- E. Clear center poly ridge cap

- F. Clear poly 2' evelight starting 1' below eve
- G. Steel side walls and end walls color: Ivory, minimum 29 gauge
- H. Steel roof color: Brown with single bubble underlayment, minimum 29 gauge
- I. Trim and soffit color: Brown

## 2.2 Solid Slider Doors

- A. Two solid slider doors sized 20'x16' and one door sized 20'x14'
- B. All slider doors to be steel studded construction, with heavy duty double truck trolley hangers, track and cover, door guides and latching hardware
- C. Location
  - 1. One 20'x16' door centered on each end wall
  - 2. One 20'x14' door centered in east eve wall

## 2.3 Entry Doors

- A. Three 36"x80" solid walk-in doors without lock set
- B. Location will be next to each slider door

## Part 3 - Execution

### 3.1 To Construct a Commercial Pole Barn Building to Engineered Blueprint

### 3.2 Cleaning and Adjustment

- A. Provide complete clean up and trash removal from the site which resulted from work of the contractor.
- B. All work to be performed under the direction of the building supervisor and will not interrupt work schedule.
- C. The proposed bidder has examined the specifications and the location of the work described and is fully informed as to the nature of the work.
