2023 BOILER AND INDIRECT WATER HEATER

BID SPECIFICATIONS

Part 1 - General

1.1 Description

The work to be done shall consist of furnishing all labor, materials and equipment for the complete and satisfactory installation of a new high efficiency condensing boiler with indirect water heater. All work shall be completed by December 15, 2023.

1.2 Submittals

- A. Contractor must comply with MIOSHA standards and regulations.
- B. Contractor is responsible for permits and inspections.
- C. Contractor must possess and produce copy with bid of:
 - 1. Commercial general liability insurance
 - 2. Worker's Compensation
 - 3. Contractor/Builder's license
- D. Site visit is mandatory prior to bid submission. Sign-in is required at the Shiawassee County Road Commission office.
- E. Full payment will be made upon completion of work.

Part 2 - Specifications

2.1 High Efficiency Condensing Boiler

- A. 100,000 to 500,000 BTU input
- B. Include an indirect water heater, 82 gallon minimum

Part 3 - Execution

3.1 Remove Old Boiler and Water Heater

3.2 Install New High Efficiency Boiler and Indirect Water Heater

3.3 Supervision and Clean-up

- A. All work to be performed under the direction of the building supervisor and will not interrupt work schedule.
- B. Provide complete clean up and trash removal from the site which resulted from work of the contractor.
- C. The proposed bidder has examined the specifications and the location of the work described and is fully informed as to the nature of the work.
