STAFF REPORTS:

Managing Director, Chris Cannon, reported on the following: A) Ruess Road Pit, still bailing material at the north point with a long reach excavator. The cost .36 is cents more per yard than the drag line. We dug some test holes near the drain and found mostly sand. Started reclamation along the Ruess Road side and plan on installing a berm B) Went to the MTA meeting in Caledonia Township, only 7 townships showed up. They changed the meetings to every other month. C) Tony Newman approached us on having to contribute to the county atlarge drain assessments. This is a common practice with other counties and is in the law. Chris will be bringing a contract to the next board meeting and it will have a cap of \$60,000 per year. D) Federal aid buyout program has no funds available for 2025.

Director of Finance and Human Resources/Clerk, Mike Girard, reported on the following: A) MTF update for payments received through October. B) Presented a draft of the proposed budget.

Superintendent of Operations, Jeremy Dietz, reported on the following: A) One minor winter event so far, November 26th and 27th, we worked the highways and the county system. B) Finished bump grinding on M-52. C) MDOT issued an advisory on roadkill, stated they will pay to bury or to dispose of. D) Graders are scraping roads as weather allows and trucks will start working with them this week. E) Bridge Crew is installing drain tile for Burns Township for a township agreement, and will be working on drainage repairs. F) Arm mowers are working in Bennington Township and New Haven Township this week. G) Crews have been cutting some trees in the districts. H) McCurdy Park Festival of Trees Light Parade we received a trophy for "on time and organized". I) SCRC was recognized with a Service Award plaque from the Shiawassee County Fairgrounds.

Equipment Superintendent, Matt Sprague, reported on the following: A) Overhead doors are up, the openers were backordered but they should be installed soon. B) The pole barn is almost done. They are short some soffit, but will wrap that up when in comes in. C) The trucks are winter ready. D) Mechanics are working on spray equipment making sure it will be ready for spring. E) Matt will be going to Truck & Trailer Friday to spec new trucks.
