C) The United Way Christmas gift delivery was a success. Chris thanked the Commissioners for allowing us to participate and said it felt really good to support families in need.

Director of Finance and Human Resources/Clerk, Mike Girard, reported on the following: A) Gave an update on some of the technology changes that we are hoping to implement. B) Update on the inventory count and adjustments.

Superintendent of Operations, Jeremy Dietz, reported on the following: A) Winter maintenance event the evening of December 18<sup>th</sup> and morning of the 19<sup>th</sup>. B) Shoulder repairs on the highway system. C) Graders are scraping gravel roads until the end of the week. That should be the end of scraping with the weather forecast. D) Bridge Crew are working on drainage repairs and tree projects. E) Arm mowers are working in Bennington Township and Antrim Township. F) Crews have been cutting some trees in the districts.
