2024 CRACKFILL MELTER APPLICATOR AND MATERIAL BID**

Bidder will provide a trailer mounted melter applicator with air compressor, boiler kettle and material for use by Road Commission personnel. Melter application and all its equipment to be fully serviced by contractor. **All bid submittals must include literature and specifications for crackseal machine. Submittals must also include a product data sheet for crackseal material.** Equipment and material shall be in accordance to the requirements of the 2012 edition of the MDOT Standard Specifications for Construction, Section 502.

Requested melter applicator is a Crafcro Super Shot 250 gallon melter with air compressor and recommended material is Crafcro Road saver 34515T and Crafcro Polyfiber III 34544.

Training of road commission personnel in proper use of the melter is to be included in the cost for material with machine.
