crew, and two in the districts. C) All township proposals are getting updated reflecting the bid prices. Meeting with the townships and getting contracts.

D) Arm mowers are in Shiawassee and Fairfield Townships. E) Finished delineator repairs on I-69, started to disc the shoulders on South M-52 Monday. F) The shoulder trucks started working on edge drops in districts.

Equipment Superintendent, Matt Sprague, reported on the following: A) Chipper box is ordered. B) Revising roof bid after talking to contractors. Originally we wanted to have on continuous run of metal. That might not be a good idea due to the expansion and contraction of the metal. We would also like to change to metal specifications. C) The shop is in pretty good shape due to a pretty light winter allowing for less wear on the equipment.
