Bid specification forms must be used. Bids can be mailed or hand-delivered to the Road Commission offices at the above address. This is a public bid opening. Results (bid tabulations) will be posted on our website.

ALL BIDS MUST BE IN A SEALED ENVELOPE AND PLAINLY MARKED ON THE OUTSIDE AS "PERRY SALT BARN BID". THE ENVELOPE SHALL INCLUDE THE NAME AND ADDRESS OF THE BIDDER.

SPECIFICATIONS

Part 1 - General

Description

- A. The work to be done shall consist of furnishing all labor, materials, and equipment for the complete and satisfactory pouring of curb/wall inside of the north, south and east walls at the Perry salt barn, located at 1816 Lansing Road in Perry, Michigan.
- B. Site visit on Friday, April 11, 2025, at 9:00 a.m. is **mandatory** prior to bid submission. Sign-in is required with the building supervisor.
- C. All work shall be completed by August 1, 2025.
- D. Any questions shall be directed to Matt Sprague, Equipment Maintenance Superintendent, at (989) 743-2228 extension 220 or msprague@shiawasseeroads.com.
- E. Full payment will be made upon completion of work.

Submittals

- Contractor must comply with MIOSHA standards and regulations.
- B. Contractor is responsible for permits and fees from Shiawassee County.
- C. Contractor must possess and produce copy with bid of:
 - 1. Commercial general liability insurance
 - 2. Worker's Compensation
 - 3. Contractor/Builder's license
 - 4. Five professional references, if requested by the building supervisor

Part 2 - Specifications

Materials and Execution

A. Curb/Wall will be 10 inches thick, 3 feet tall with a slight slope at top (highest point at wall).

- B. Epoxy coated #4 rebar, epoxied into sidewall 8 inches deep, 6 inches out of wall, 2 rows on 16-inch centers: first row 12 inches off floor, second row 24 inches off floor.
- C. Epoxy coated #4 rebar, epoxied into floor 8 inches deep, 30 inches high on 16-inch centers, 5 inches away from wall.
- D. Surface of existing walls and floor shall be swept clean and free of debris and salt.
- E. Concrete will be 4,000 PSI wall mix with Idrocrete KR1000 or equivalent added in per manufacturer's specifications

Cleaning and Adjustment

- A. Provide complete clean up and trash removal from the site which resulted from work of the contractor.
- B. All work to be performed under the direction of the building supervisor and will not interrupt work schedule.
- C. The proposed bidder has examined the specifications and the location of the work described and is fully informed as to the nature of the work.
